

Federal AML funding to West Virginia


Annual AML funding in West Virginia **increased by 742%** since the Bipartisan Infrastructure Law (BIL) passed (i.e. increase from 2021 to 2022)

**Over \$2.1 billion** is <u>coming to West Virginia</u> over 15 years (2022-2036) under the BIL



Annual AML funding in Pennsylvania **increased by 890%** since the Bipartisan Infrastructure Law (BIL) passed (i.e. increase from 2021 to 2022)


**Over \$3.7 billion** is <u>coming to Pennsylvania</u> over 15 years (2022-2036) under the BIL



Federal AML funding to Pennsylvania

Annual AML funding in Ohio **increased by 914%** since the Bipartisan Infrastructure Law (BIL) passed (i.e. increase from 2021 to 2022)


**Over \$697 million** is <u>coming to Ohio</u> over 15 years (2022-2036) under the BIL

**Over \$1.1 billion** is <u>coming to Kentucky</u> over 15 years (2022-2036) under the BIL

## How are AML contracts changing in Kentucky?

Smallest Contract	\$22,700	\$52,900
Largest Contract	\$1,587,330	\$3,984,437



## What's the total value of AML contracts in recent years?

The BIL was enacted in November of 2021.

Throughout 2022, Kentucky DAML selected and designed its first BIL-funded AML projects.

In January of 2023 the first BIL-funded contracts were awarded.





## How large is the *average* AML contract in Kentucky?

The average dollar value of AML contracts in Kentucky was **286% larger** in 2023 relative to the 2020-2022.


